No. 87.-AN ACT to amend Article Three "mousand Three Hundred and Thirty-Three of the Civil Code.

No. 89. AN ACT to incorporate the Louisiana Medico Chirugical Seciety.

Section 1. Be it enacted by the Senate and House of Representatives of the State of Louisiana in General Assembly convened, That Doctors J. B. Beugnot, H. Tricou, S. de Valletti, U. Landreaux, P. A. Lambert, I. Labatut, Dowler, Piussan, Harlan, Mercier, Dupas, Barbe, Thomas, C. A. Luzenberg, J. Q. Osborne, H. Lewis, John Rhodes, Slade, Easton. Davezac, Hester, Ridgeley and Fenner, and all other persons who may be legally hereafter associated with them, be and they are hereby created a body corporate, under the title of "The Louisiana Medico-Chirurgical Society," and under that name and title shall have the right of succession; be capable of acquiring, possessing, enjoying, using and owning any property, moveable or immoveable, and of alienating and disposing of the same, receive donations; make valid contracts with persons and corporations; manage their own concerns; claim, enforce and defend judicially that which may be due or belong to them; make by laws and rules for their own government, and have a common treasury—the said corporation being subject to the general laws of the State relative to corporations: And Provided, that all moneys and property of every kind it may possess or own shall be exclusively applied for the benefit of the corporation, and in no manner contrary to the purposes for which the Society is established.

Caddo DeSoto Natchitoches Sabine Red River

### DESOTO PARISH BOUNDARIES

Foreword: The Parish of DeSoto was created by Act 88 of 1843, principally out of portions of the original areas of Natchitoches and Caddo Parishes, as these latter parishes then existed. Natchitoches was one of the nineteen (19) original parishes simultaneously created under Act 1 of 1807, and Caddo was created out of the northwest corner of the original area of Natchitoches Parish by an Act approved January 18, 1838. For the approximate location and extent of the original Parish of Natchitoches, see Wm. Darby's map of 1816. The boundary lines of DeSoto Parish as described in Act 88 of 1843 can be readily traced upon the Official Map of Louisiana, 1937 Edition, with the aid of the pertinent footnotes superimposed by your Research Engineer upon the copy of the excerpt from said Act 88 of 1843, placed for reference further towards the back of the DeSoto Parish Boundary Folio. It may be well to here incidentally mention the fact that Sabine Parish had been created by Act 46 of 1843, thus antedating the creation of DeScto Parish by only a very few days, at the most; yet, it was apparently sufficiently in advance for Sabine Parish to lose to its slightly newer neighbor a strip of land - next to its own quite recently established northern boundary line - approximately 3 miles wide and 12 miles long, that was defined by the latest of these two Acts as belonging in DeSoto Parish.

Besides the area taken from the original area of Caddo Parish for the purpose of creating Sabine and DeSoto Parishes in 1843, additional original area of Caddo Parish was transferred to DeSoto Parish under Act 135 of 1845, this time leaving the DeSoto-Caddo boundary line as it now exists and as it is, for the most part, correctly shown on the Official Map of Louisiana, 1937 Edition. However, under the previsions of Act 39 of 1871 as amended and affected by Act 70 of 1878, and as affected by a decision of the Court in 1906, portions of both DeScto and Caddo Parishes - as well as portions of Bossier, Bienville and Natchitoches Parishes were devoted to the formation of Rod River Parish; thus, leaving the boundaries of the Parish of DeSoto as they now exist, to wit: Beginning at a point on the Texas-Louisiana State boundary line along the west bank of the Sabine River, opposite the line at the center of Township 10 North; thence due east across the Sabine River and along the section line at the center of Township 10 North until the range line between Ranges 10 and 11 West is intersected; thence due north along said range line between Ranges 10 and 11 North until Wallace Bayou is intersected; thence down the center of Wallace Bayou in a northeasterly direction - following the sinuosities of the stream - until it empties into Dolet's Bayou; thence down the center of Dolet's Bayou in an easterly direction to the mouth of Jim's Bayou; thence up the center of Jim's Bayou in a northerly direction until Bayou Pierre is reached; thence up along said Bayou Pierre in a northwestern direction (the position with relation to the center or of either bank of the stream being left indeterminate in the prevailing Act, No. 70 of 1878) to Bayou Pierre; thence up the center of Bayou Pierre in a northerly direction continuously - passing through both Bayou Pierre Lake and Cannisnia Lake - to the mouth of Bayou Wallace; thence up

the center of Bayou Wallace, in a northwesterly direction, to Wallace Lake; thence through Wallace Lake, along the center or thread of the channel thereof, to the mouth of Cypress Bayou; thence up Cypress Bayou - following the sinuosities of the center or thread thereof - to the mouth of Keatchie Bayou; thence up Keatchie Bayou, along the center thereof, in a southwesterly direction until it intersects the section line between sections eighteen and nineteen, in range fifteen and township fourteen; thence due west along said section line to the Louisiana-Texas State boundary line; thence due south along said State boundary line until the west bank of the Sabine River is intersected; thence down the west bank of Sabine River - which constitutes the boundary line between the States of Louisiana and Texas - to the point of beginning. (See the footnote on the copy of the judgment by the Court in the Caddo vs. DeSoto suit, filed in the DeSoto Parish Boundary Folio).

At one time or another, the following chronologically presented Acts (copies of excerpts from which have been filed for reference further towards the back of the DeSoto Parish Boundary Folio, with pertinent footnetes superimposed thereon by your Researcher) bore either directly or indirectly on the boundaries of DeSoto Parish, viz:

Act of the 8th U.S. Congress (1st Session), approved March 26, 1804, p. 1293, that "erected Louisiana into two territories" and provided for the temporary government thereof. The Louisiana referred to therein as being divided was the area that had previously constituted the quite spacious "Province of Louisiana". For the location and extent of the Territory of Orleans, so created, see Bmi. Lafon's map of 1806. It was identical with the region that in 1812 became the State of Louisiana, after the addition of the area that now embraces the eight so called "Florida Parishes" of the State. This Act of Congress is now obsolute.

Act 25 of 1805, Legislative Council of the Territory of Orleans, p. 144, that divided the Territory of Orleans into twelve (12) Counties, one of which was Natchitoches, from a portion of the original area of which DeSoto Parish was afterwards created. For the relative location and extent of these twelve (12) Counties, see Bmi. Lafon's map of 1806. This Act is now obsolete.

Act 1 of 1807, Legislative Council of the Territory of Orleans, Section 9, p. 10, that simultaneously created not only the Parish of Natchitoches (out of a portion of whose original area DeSoto Parish was created in part in 1843) but eighteen (18) others, the location and extent of which are indicated in a more or less general way on Wm. Darby's map of 1816. Collectively these were the first Parishes legally created as such; although, as previously recounted elsewhere, the name parish had, during preceding years, been employed by the Catholic Church to designate the ecclesiastic areas over which each of its then widely separated places of worship had spread its influence. Perusal of the copy of an excerpt from this Act - placed for reference towards the back of the DeSoto Parish Boundary Folio - will reveal the fact that this Act failed to give any specific description of the location and extent of any of these original nineteen (19) civic or political parishes, thereby rendering it necessary to depend upon the largely indirect and vague descriptions contained in subsequent Acts that either subdivided the criginal parishes into new parishes or that related to boundary lines of contiguous parishes. This Act is now obsolete for the most part.

Ordinance by Governor Wm. C.C. Claiborne, under date of
December 7, 1810, that was bound with the Acts of 1810, p. 210, and that
purported to create an additional (the thirteenth) county to be known as
the County of Feliciana. However, some historians are dubious as to the
constitutionality of this Ordinance, assuming that the territory concerned
had never been definitely ceded to the United States. Moreover, Act 1 of
1807 (under the provisions of Sections 9, 32 and 33 thereof) is quite
generally held to have effectually nullified the existence of the original
twelve (12) counties that had been created and established under the provisions of Act 25 of 1805, thus tending to arouse at least some misgiving
as to the propriety of either creating or attempting to create any additional "counties". This latter thought seems to have been overlooked
or disregarded to some extent as evidenced by what follows next,

Act 12 of 1812, p. 48, that defined the limits of the---- "Countrof Natchitoches" ---- and, that in doing so, mentioned other contiguous---- "Counties". It will be noticed, however, that on Wm. Darby's map of 1816, the designation of County (which had appeared so conspicuously on Bmi. Lafon's map of 1806) was - rather significantly - entirely omitted. This Act 12 of 1812 is now obsolete.

Act approved January 18, 1838, that created the Parish of Caddo, out of the northwestern portion of the original Parish of Natchitoches, thereby establishing Caddo Parish in its position just west of Red River, immediately opposite the western boundary of Claiborne Parish, as the latter then existed. (See Catesby Graham's map of 1838). This Act is now obsolete with respect to a considerable area that was originally included in the southern part of the Parish, and while none of the available authentic maps of the State specifically shows the location and extent of Caddo Parish as thus created in 1838, the footnotes superimposed by your Researcher on the copy of the excerpt from the creating Act - filed for reference further towards the back of the DeSoto Parish Boundary Folio - will enable anyone to readily trace upon the office copy of Catesby Graham's map of 1838 (where certain of the lines described in the Act have been superimposed in lead pencil) the boundary lines of the Farish of Caddo as originally created.

Act 46 of 1843, p. 26, that created the Parish of Sabine, out of a portion of the original area of Natchitoches Parish bordering on the Sabine River. This Act is now obsolete, having been affected by Act 88 of 1843 and other subsequent Acts; however, the boundary lines described therein can be readily traced by utilizing the office copy of Catesby Graham's map of 1838, and H. P. Marcot's map (date obliterated) of Caddo, Claiborne and Natchitoches, for the purpose.

It was Act 88 of 1843, p. 52, that created the Parish of DeSoto, as set forth rather fully in the Foreword on Page 1 of this Report. This Act is now very largely obsolete; however, the boundaries described therein can be easily traced on Catesby Graham's map of 1838, especially if the footnotes on the copy of the excerpt of this Act filed for reference further back in the DeSoto Parish Boundary Folio are consulted. A detailed description of the boundaries of DeSoto Parish, as it now exists will als be found in the forepart of this Report; and, the Official Map of Louisiana, 1937 Edition, correctly shows its present day boundaries, except perhaps of that part thereof located at and immediately below the township

line between Townships 14 and 15 North, in or through Lake Cannisnia, which part may not have been affected by the Court decision in the suit of Caddo vs. DeSoto in 1906 to the extent believed to be the case when the 1937 Edition of the Official Map of Louisiana was being prepared for publication. There, the location of the DeSoto-Caddo and of the DeSoto-Red River parish boundary lines should perhaps be regarded for the present as being somewhat indefinite.

Act 135 of 1845, p. 77, that altered the boundary line between the parishes of DeSoto and Caddo, in such way as to annex to DeSoto Parish the portions of Caddo Parish which were located - prior thereto - "south and west of the Bayou Pierre River and Cypress Bayou". This is still the prevailing Act; however, the decision of the Court in the case of Caddo vs. DeSoto, No. 16566, 119 La. 120, 43 South 978 - Counties 7, in 1906 established the location of that part of the eastern boundary - above the township line between Townships 14 and 15 North - at a different position from the one it had previously been believed by many to have belonged, to thereafter be recognized as following the thread of the channel near the center of Lake Cannisnia, and thence up the center or thread of Bayou Pierre, above the Lake, to the mouth of Bayou Wallace. (See copy, in the Caddo Parish Boundary Folio, of the judgment in that case, as well as of the map referred to therein as "Exhibit B").

Act 219 of 1848, pages 145 and 146, that authorized a survey to determine whether a new parish - to be called Red River Parish - could be created within a certain designated area (involving contiguous portions of DeSoto, Natchitoches, Caddo, Bossier and Claiborne, as said parishes then existed) and possess the required number of male citizens to be entitled to creation under the Constitution of the State. Although this Act proved to be abortive, the Parish of Red River was later on created by Act 39 of 1871, approximately covering the area described in this abortive Act.

Act 203 of 1854, p. 141, that removed uncertainty in regard to a part of the south half of Township 10 North - between the Sabine River and the range line between Ranges 10 and 11 West - being definitely embraced within Sabine Parish. The provisions of this Act still prevail. (In addition to this Act - a copy of an excerpt from which, with explanatory footnotes superimposed thereon, has been filed for reference further towards the back of the DeSoto Parish Boundary Folio - see Acts 46 and 88 of 1843, both of which latter were amended and affected by the 1854 Act.)

Act 39 of 1871, p. 86, that created the Parish of Red River from portions of DeSoto, Bienville, Bossier, Caddo and Natchitoches Parishes; but, that is now largely obsolete and was replaced - together with Act 92 of 1872 - by Act 70 of 1878.

Act 92 of 1872, p. 147, that amended and re-enacted Section 2 of Act 39 of 1871, in such way as to specify that the Natchitoches-Red River Parish boundary line should follow Bayou Lumbra from the latter's mouth up to Dolet's Bayou. This feature was incorporated in Act 70 of 1878 that is now the prevailing Act.

Act 70 of 1878, p. 108, that repealed the preceding Act 92 of 1872, and that amended and re-enacted Section 2 of Act 39 of 1871, in

such way as to fix and define the Red River-DeSoto, the Natchitoches-Red River, the Red River-Bienville, the Red River-Bossier, and the Red River-Caddo Parish boundary lines. This Act 70 of 1878 is still the prevailing Act, except perhaps for that portion thereof that described the boundary line through the full length of Lake Cannisnia as being along the eastern bank of that Lake, and as continuing thence northward along the eastern bank of Bayou Pierre as far up stream as the intersection of Bayou Pierre with the township line between Townships 14 and 15 North, in Range 12 West. Along this particular stretch of the DeSoto Parish boundary line the ruling of the Court in the year 1906, in the case of the boundary suit of the Parish of Caddo vs. Parish of DeSoto, placed the DeSoto-Caddo boundary line along the thread of the channel within that part of Lake Cannisnia (near the middle thereof) that was situated above the township line dividing Townships 14 and 15 North, as well as in that part of Bayou Pierre above said township line - all to conform with the map made on January 1, 1906, by L. H. Bell, marked "Exhibit B", a copy of which map together with a copy of the decision of the court, is filed for reference in the Caddo Parish Boundary Folio.
